## Invoke Insights ® Privacy Policy

**We recognize that your privacy is very important.** This privacy policy covers the policies of Free The Work (f/k/a Free The Bid) ("FTW") on the collection, use, and disclosure of your information, including any personally identifiable information or other data collected that could directly or indirectly identify you ("Personal Data") when you access the Invoke Insights® platform at <a href="www.invokeinsights.org">www.invokeinsights.org</a> (the "Site"), the surveys or anytime you use our other Invoke Insights products or services (the Site, surveys and other Invoke Insights products and services, altogether, the "Services"). The FTW Privacy Policy does not apply to these Services.

Each time you use our Services, you consent to the collection, use and storage of the collected information as described in this Privacy Policy. Please read it carefully and contact us at <a href="mailto:invoke@freethework.com">invoke@freethework.com</a> if you have any questions.

#### 1. What information do we collect?

**Updates Signup Information.** If you wish to receive email updates from FTW, we will ask you to provide the following information:

- Name
- Email address
- Your role in the production industry (for example, whether you hire crew members or you are a crew member. This is not Personal Data).

**Crew Member--Your Anonymous Input to Our Narrative Form.** If you are a crew member, to help us empower your visibility, you may have the opportunity to fill in a narrative form to tell your story. You may have the opportunity to tell us about the following, among others:

- Your age range;
- Your gender;
- Your pronouns;
- Your sexual orientation;
- Your birth country;
- Your ancestry;
- Your language skills;
- Your veteran status;
- Your disability status:
- Your role on the set; and
- Your day rate.

Once this information enters our system, they will be scrambled to produce summarized reports with aggregate data. The summarized reports will NOT identify you. You can always choose not to provide this information by selecting "Prefer not to say."

**Crew Member—Enrollment Information.** If you wish to enroll, which is completely optional, we will collect your phone number. We will use your phone number for contact administrative purposes. For example, we will send you text messages to invite you to complete the on-set survey. We will also use your phone number to send you an authentication code, which you will need in the future to pre-fill a form

for other productions with information you have submitted previously. Your phone number will be stored in an encrypted way in our database. No phone numbers will be directly linked to your anonymous input.

**Input to Our Intake Form.** If you are a brand, production company, agency or studio interested in participating in our Invoke Insights program, to help us track your project, you will be invited to fill in an intake form to tell us about your project. You will be asked to provide information which includes production/project name, production type, production start and end dates, company you are associated with, your name and work email address (altogether, the "Project Information").

#### **Automatically Collected Online Usage Activity**

As is true of most websites, we gather certain information automatically when you visit our Site. FTW uses technology to provide online customer support and data to improve or customize your user experience. These technologies help us track and analyze user traffic and activity, administer and update our Site, to improve our performance. This information helps us understand your needs and suggest products and services relevant to you.

#### Log Files

We keep track of activity on our Site via log files stored on our web servers. We collect information such as IP address, browser type and version, and pages you view. We also keep track of how you got to our Site and any links you click on to leave our Site. Once you leave our Site, we do not track you. We use your website activity to assist us in offering you a personalized Site experience, assist you with technical support, diagnose problems with our server, administer our websites, and to tailor our product and offerings to you.

#### Web Beacons

We access and set cookies using web beacons, also known as single-pixel GIFs which are invisible graphical images. These web beacons provide us useful information regarding our Site such as which pages users access. When we send you emails, we may include a single-pixel GIF to allow us to determine the number of people who open our emails. When you click on a link in an email, we record this individual response to allow us to customize our offerings to you.

#### Cookies

To collect this information, a cookie is set on your computer or device when you visit our Services. Please see section below "How We Use Cookies" for more discussion on this topic.

In some countries, including countries in the European Economic Area ("EEA"), United Kingdom and Switzerland, the information referenced above in this paragraph may be considered personal information under applicable data protection laws. You can set your browser to remove or reject cookies; however some Services may not work properly without cookies.

**Mobile Device Data.** When you access our Services through a mobile device, we also collect certain mobile device information automatically, including, but not limited to, the type of mobile device you use, your mobile operating system, and the type of mobile Internet browsers you use.

**Program & Activity Updates.** We collect your name and email address if you sign up to receive emails, invites and newsletters from us regarding our programs and activities.

**Services and Customer Support.** We collect information such as your name and email address to the extent necessary for us to provide the Services that you have requested and/or to provide customer support.

#### 2. How we use cookies?

Cookies are small text files which are transferred to your computer or mobile device when you visit a website or app. We use them to remember your preferences, improve your user experience, and help us understand how people are using our Services, so we can make them better. Cookies can be session cookies, which expire once you close your web browser. Cookies can also be persistent cookies, which stay on your device or a set period of time or until you delete them. FTW uses the following types of cookies:

- Strictly Necessary Cookies: These cookies are necessary to allow us to operate our Services as you have requested.
- Performance/Analytics Cookies: We use cookies and other similar technologies to analyze how our Services are accessed, is used, or is performing. We use this information to maintain, operate, and continually improve our Services. We may also obtain information from our email newsletters or other communications we send to you, including whether you opened or forwarded a newsletter or clicked on any of its content. This information tells us about our newsletters' effectiveness and helps us ensure that we're delivering information that you find interesting.
- **Functional Cookies**: These cookies help us remember your preferences and settings to enhance your user experience.

Using our Services without cookies is also possible. In your browser, you can deactivate the saving of cookies, limit them to particular websites, or set the browser to notify you when a cookie is sent. You can also delete cookies from your PC hard drive at any time (file: "cookies"). Please note that in this case you will have to expect a limited page presentation and limited user guidance. Most web browsers allow some control of most cookies through the browser settings. #### 3. How do we use the collected information?

We use the information we collect for the purposes described in this Privacy Policy, as covered in any agreement that incorporates this Privacy Policy, or as disclosed to you in connection with our Services. For example, we will use your information to:

- Provide and deliver products or services, including email updates, conduct crew member surveys, enable crew members to pre-fill their narrative forms, and track production;
- Produce summarized reports utilizing aggregate data to generate actionable insights to enable intentional hiring practices and establish industry benchmarks;
- Operate and improve our operations, systems, products, and services;
- Respond to your comments and questions and provide customer service;
- Provide service and support, such as sending confirmations, technical notices, updates, security alerts, and administrative messages and providing customer support and troubleshooting;
- Communicate with you and your referrals about promotions, upcoming events, and news about products and services offered by FTW and our selected partners;
- Enforce our terms and conditions or protect our business, partners, or users;
   or
- Protect against, investigate, and deter fraudulent, unauthorized, or illegal activity

**Electronic Communication.** Consistent with the above purposes and as permitted by applicable law, we may communicate with you via electronic messages, including email or text message to provide you with the Services. Message and data rates may apply for any text messages sent to you from us and to us from you, and we are not liable for the cost of any such messages. **You are not required to provide us with your phone number. By providing us with your phone number to enroll, you consent to receiving text message from us. You can opt-out by texting "NO" or "STOP" when prompted by the text message.** 

**Aggregate Data.** Our mission is to enable intentional hiring practices and establish industry benchmarks by generating big picture trends utilizing aggregate data. Aggregate data are data combined from several measurements. When data is aggregated, groups of observations are replaced with summary statistics based on those observations. For example, our summarized reports will only show the gender composition of the production team as a whole, the reports will never show gender composition broken down into individuals. As this aggregate data does not identify you personally, it will not be treated as Personal Data under this Privacy Policy. The summary reports embodying the aggregate data will be shared with third parties.

**Legal Basis For Processing.** When we process your Personal Data we will only do so where at least one of the following applies:

- Provide our service to you: Most of the time, the reason we process your Personal Data is to perform the contract that you have with us. If you provide us with your email to sign up for our email updates, we will use the email address to email you the updates. If you provide us with your name and email address to set up crew member surveys, we will use your email address to contact you to set up the crew member surveys. If you are a crew member and you fill in a narrative form with your demographic information, we will scramble such demographic information to produce summarized reports with aggregate data to generate actional insights to enable intentional hiring practices and establish industry benchmarks. If you are a crew member and you choose to enroll with your phone number, we will use your phone number to send you administrative text messages and authentication code to enable you to pre-fill a form for other productions with information you have submitted previously.
- Legitimate interests: We may use your Personal Data where we have legitimate interests to do so. For instance, we may use Personal Data to generate aggregate data to provide us with insights as to our progress in terms of achieving our mission. We will also process Personal Data for administrative, fraud detection and other legal purposes.
- *Consent:* From time to time, we may ask for your consent to use your Personal Data for certain specific reasons. You may withdraw your consent at any time by utilizing the opt-out features available in your account settings, or by contacting us at the address provided at the end of this Privacy Policy.
- *Legal Compliance:* When it is necessary for us to use your Personal Data to comply with a legal obligations.

# 4. Is Information Collected by or Disclosed to Third Parties by using the Services?

We do not share, sell or rent to third parties your information except as described in this Privacy Policy. Examples of instances in which we share your information are provided below:

a. **Third party service providers**. We, like many businesses, sometimes engage other companies to perform certain business-related functions on our behalf so that we can focus on our core business. Examples of these services include, but are not limited to, website evaluation and data analysis, data visualization, AI marketing automation and distribution, site search and discovery services and, where applicable, data cleansing, and marketing and promotional material distribution. We authorize them to use this

Personal Data only in connection data security and privacy standards.

- b. Business transfers. We may sell, assign, buy, transfer or otherwise acquire or dispose of certain of our businesses or corporate assets. In the event of such or similar event, Personal Data we collected from you may be part of the transferred assets. We may also share Personal Data with our auditors, attorneys or other advisors in connection with the forgoing corporate transactions. You acknowledge and agree that any successor to or acquirer of us will continue to have the right to use your Personal Data and other information in accordance with the terms of this Privacy Policy.
- c. Links to Third Party Platforms. We may provide you with the option to connect with third party services, including websites, applications and services through "plug-ins," widgets, buttons and other third party features on and connect with our websites, communications or products. To do so, we may share your account registration data with such third party platforms to enable them to authenticate your account. Third party platforms which we link to, may have information practices that are different from ours. This Privacy Policy does not apply to the activities of the third parties when they are collecting or using data for their own purpose or on behalf of others. We are not responsible for the activities of these third parties. We encourage you to review their privacy policies to understand how they use your information.
- d. Aggregate Data. Our mission is to enable intentional hiring practices and establish industry benchmarks by generating big picture trends utilizing aggregate data. Aggregate data are data combined from several measurements. When data is aggregated, groups of observations are replaced with summary statistics based on those observations. For example, our summarized reports will only show the gender composition of the production team as a whole, the reports will never show gender composition broken down into individuals. As this aggregate data does not identify you personally, it will not be treated as Personal Data under this Privacy Policy. The summary reports embodying the aggregate data will be shared with third parties.
- e. Website Analytics. We use third-party web analytics services—like Google Analytics and Lucky Orange—in our online services. These service providers help us analyze how users navigate our online services. Information collected as a part of Google Analytics is automatically sent to Google, and Google may use cookies to help with the analysis. Google Analytics may provide demographic, interest-related, geographical and referral information that FTW may use to better understand our customer base. Session User ID tracking and stitching may also be used to further understand how our users access our websites from different devices. To learn more about Google Analytics or download an opt-out browser addon, please click here. We also use Lucky Orange analytics system to help improve usability and customer experience, and Lucky Orange may use cookies to help with the analysis. Lucky Orange

may record mouse clicks, mouse movements, and scrolling activity. Lucky Orange may also record keystroke information that is voluntarily entered on this Site. Lucky Orange does not track this activity on any site that does not use the Lucky Orange system. To learn more about Lucky Orange's tracking activities and how to restrict their tracking activities, please visit their Privacy Policy.

- f. Legal requirements. We may disclose your Personal Data if required to do so by law (including, without limitation responding to a subpoena or request from law enforcement, court or government agency or other public authorities) or in the good faith belief that such action is necessary (i) to comply with a legal obligation, (ii) to protect or defend our rights, interests or property or that of other customers or users, (iii) to act in urgent circumstances to protect the personal safety of users of the Services or the public, or (iv) to protect against legal liability or potential fraud, as determined in our sole discretion.
- g. **Your consent**. If we intend to use any of your Personal Data collected in any manner that is not specified herein, we will inform you of such anticipated use prior to or at the time at which such Personal Data is collected or we will obtain your consent subsequent to such collection but prior to such use. In short, we will honor the choices you make regarding your Personal Data and will inform you about any other intended uses of such information.

### 5. Linking to or from Third Party Social Media Platforms.

Users may follow FTW on Facebook, Instagram, Twitter and other social media platforms as made available from time to time. Users should click on the hyperlinks for each site to review the applicable privacy policies for more detail about information collected from these sites.

#### 6. How Does FTW Comply with the Children's Online Privacy Protection Act?

Our Services are directed toward a general audience and are not directed at nor intended for use by children. We do not knowingly collect information from children under the age of 13 without parental consent. If a parent or guardian becomes aware that his or her child has provided us with information without their consent, he or she should contact us at <a href="mailto:invoke@freethework.com">invoke@freethework.com</a>. We will delete such information from our files within a reasonable time.

#### 7. GDPR+ Data Protection Rights.

If you are located in countries that are within the European Economic Area (the "EEA"), Switzerland or UK, GDPR and its Swiss and UK GDPR counterparts give you rights with respect to your personal data, subject to any exemptions provided by the law, including the following rights:

- Reguest access to your Personal Data;
- Request correction or deletion of your Personal Data;
- Object to our use and processing of your Personal Data;
- Request that we limit our use and processing of your Personal Data; and
- Request portability of your Personal Data.

We will consider all such requests and provide our responses as soon as we can. Please note, however, that personal information may be exempt from such requests in certain circumstances, which may include circumstances where we need to keep processing your personal information for our legitimate interests or to comply with a legal obligations. Users located in EEA, United Kingdom or Switzerland also have the right to make a complaint to a government supervisory authority.

#### 8. Argentina Data Protection Rights.

If you are located in Argentina, Argentina's Personal Data Protection Law No. 25, 326 gives you rights with respect to your personal data, subject to any exemptions provided by the law, including the following rights:

- Request access to your Personal Data. Requests can be made free of charge and at six-monthly intervals unless there is a legitimate reason for more frequent access. Upon receipt of your request, we will provide the requested information within 10 days.
- Request to rectify, update, and, when applicable, delete or keep confidential
  your Personal Data. If your Personal Data is transferred to a third party, we
  will notify that third party of any rectification or deletion of personal data
  within five (5) days of such amendments being made.

Provided that you are enrolled, you can access, rectify, update, and applicable, delete or keep confidential, your Personal Data by contacting us at <a href="mailto:invoke@freethework.com">invoke@freethework.com</a>. We will consider all such requests and provide our responses as soon as we can. Please note, however, that personal information may be exempt from such requests in order to protect Argentina's national defense, order and public safe, or third parties' rights or interests. Users located in Argentina also have the right to make a complaint to a government supervisory authority.

#### 9. Cross-Border Data Transfers

Sharing of information laid out in Section 4 sometimes involves cross-border data transfers, for instance to the United States of America and other jurisdictions. FTW may also subcontract processing to, or share your Personal Data with, third parties located in countries other than your home country. Your Personal Data, therefore, may be subject to privacy laws that are different from those in your country of residence.

Our Services are hosted on Amazon Web services ("AWS"). Like FTW, helping to protect the confidentiality, integrity, and availability of customer data is of the utmost importance to AWS, as is maintaining customer trust and confidence. By using our Services, you consent to your personal information being transferred to our servers as set out in this policy.

Where our Services allow for users located in the European Economic Area ("EEA"), UK, Switzerland or Argentina, and when we transfer their Personal Data to countries outside of the EEA, UK, Switzerland or Argentina as processors, we transfer the Personal Data in accordance with applicable privacy laws and, in particular, those appropriate contractual, technical, and organizational measures as described in the Standard Contractual Clauses approved by the EU Commission and the Argentinian Model Contractual Clauses adopted by the Data protection Agency of Argentina, as amended from time to time. Both the Standard Contractual Clauses are and the Argentinian Model Contractual Clauses are commitments between companies transferring personal data, binding them to protect the privacy and security of your data.

#### 10. U.S. Privacy Laws

If you are located in the United States, this Privacy Policy explains how we collect, use and disclose your personal information under California, Colorado, Connecticut, Montana, Oregon, Texas, Utah and Virginia privacy laws, to the extent applicable to us. We call these laws collectively, the "U.S. Privacy Laws." As of the last date when this Privacy Policy was updated, we are not yet subject to the U.S. Privacy Laws. Although we are not yet subject to the U.S. Privacy Laws, our Privacy Policy currently describes rights afforded to data subjects under GDPR that are similar to the rights afforded to data subjects under the U.S. Privacy Laws. It is contemplated that in the event that the U.S. Privacy Laws apply to us, we will update our Privacy Policy to describe the rights afforded to data subjects under the U.S. Privacy Laws. Regardless, we do not sell or share personal information. We do not disclose Personal Data to third parties for the purpose of engaging in targeted advertising. We will closely monitor the development of the U.S. Privacy Laws that may apply to our future activities and will implement reasonable administrative, technical and physical security measures for compliance.

#### 11. How long does FTW retain information collected?

We follow generally accepted standards to store and protect the Personal Data we collect, both during transmission and once received and stored, including utilization of encryption where appropriate. We retain Personal Data only for as long as necessary to provide the Services you have requested and thereafter for a variety of legitimate legal or business purposes. These might include retention periods (i) mandated by law, contract or similar obligations applicable to our business operations; (ii) for preserving, resolving, defending or enforcing our legal/contractual rights; or (iii) needed to maintain adequate and accurate business and financial records. ## 12. What is FTW's Security Policy?

We have implemented reasonable administrative, technical and physical security measures to protect your personal information against unauthorized access, destruction or alteration. For example, we limit access to this information to authorized employees and contractors who need to know that information in order to operate, develop or improve our Services. However, although we endeavor to provide reasonable security for information we process and maintain, no security system can ever by 100% secure.

#### 13. How Does FTW Respond to "Do Not Track" Signals?

"Do Not Track" is a feature enabled on some browsers that sends a signal to request that a web application disable its tracking or cross-site user tracking. At present, FTW does not respond to or alter its practices when a Do Not Track signal is received.

#### 14. How Will I Be Notified of Changes to Your Privacy Policy?

If FTW makes material changes to its Privacy Policy, it will notify you by: (i) changing the Last Updated Date at the top of the Privacy Policy, (ii) sending an email to its users, and/or (iii) adding a statement to the Site.
